LAUDERDALE COUNTY INELIGIBLE AREA BOUNDARY LINE

(11/1/99)

Begin at the NW corner of Section 28, T7N, R15E;

Run East to the NE corner of Section 30, T7N, R16N;

Run North to the NW corner of Section 20, T7N, R16W;

Run East to the NE corner of Section 23, T7N, R16W;

Run South to SE corner of Section 35, T7N, R16W;

Run East to where the section line intersects with

Sweet Gum Bottom Road;

Run southerly down Sweet Gum Bottom Road to a point

on the northern line of Section 23, T6N, R16E;

Run East to the NE corner of Section 24, T6N, R16E; Run South to the SE corner of Section 36, T6N, R16E;

Run West to the SW corner of Section 35, T6N, R16E;

Run North to the SW corner of Section 26, T6N, R16E; Run West to the SE corner of Section 29, T6N, R16E;

Run South to the SE corner of Section 32, T6N, R16E;

Run West to the SW corner of Section 33, T6N, R15E;

Run North to the NW corner of Section 28, T7N, R15E to the POB.

In areas where the boundary line coincides with a street or road, it has been determined that frontage on both sides of the street or road would be considered ineligible areas.



LEE COUNTY, MISSISSIPPI INELIGIBLE BOUNDARY LINE

Begin at the SW Corner of Section 1-T9S-R5E
Run South ½ mile to the Tupelo City Limits
Run South with the Tupelo City Limits to the SW Corner of the NW ¼ of Section 13-T9S-R5E
Run West with the Tupelo City Limits to the SW ¼ of the NW ¼ of Section 14-T9S-R5E
Run North West with the Tupelo City Limits to the SW Corner of the East ½ of the NE ¼ of Section 9-T9S-R5E
Run North with the Tupelo City Limits to the North Section Line of Section 9-T9S-R5E
Run West with the Tupelo City Limits to the NW Corner of the of the NE ¼ of Section 8-T9S-R5E
Run South with the Tupelo City Limits approximately 5-½ miles to the SW Corner of the NE ¼ of Section 5-T10S-R5E
Run East with the Tupelo City Limits to the NW corner of the SW ¼ of Section 4-T10S-R5E
Run South with the Tupelo City Limits to the NW Corner of Section 9-T10S-R5E
Run East with the Tupelo City Limits along the north line of Section 9-10-5 to the NW Corner of Section 10-T10S-R5E
Run South with the Tupelo City Limits to the NW Corner of Section 15-T10S-R5E
Run East with the Tupelo City Limits to the NW Corner of the of the NE Quarter of Section 15-T10S-R5E
Run South with the Tupelo City Limits to a point just north of the SW Corner of the SE ¼ of Section 15-T10S-R5E
Run East with the Tupelo City Limits to a point just north of the SW Corner of the SE ¼ of Section 14-T10S-R5E
Run South with the Tupelo City Limits to the Southwest Boundary of Tupelo
Run East with the Southern boundary of the Tupelo City to the West Line of Section 19-T10S-R 6E
Run North with the Tupelo City Limits to the NW Corner of Section 19-T10S-R6E
Run East with the Tupelo City Limits to the NE Corner of Section 19-T10S-R6E
Run North with the Tupelo City Limits to the NW Corner of the SW ¼ of Section 17-T10-S-R6 E
Run East with the Tupelo City Limits to the NW Corner of the SW ¼ of Section 16-T10S-R6E
Run North with the Tupelo City Limits to the point where the East side of Section 16-T10S-R6E, intersects with the Tulip Creek
Run North East with the Tupelo City Limits, meandering with Tulip Creek, to the West Line of Section 34-T9S-R6E
Run North with the Tupelo City Limits to the NE Corner of the SE ¼ of Section 22-T9S-R6E
Run West with the Tupelo City Limits to the NE Corner of the SE ¼ of Section 21-T9S-R6E
Run South with the Tupelo City Limits along section line to the South ROW of Highway 78
Run North West with the Tupelo City Limits along the south ROW of Highway 78 to Intersection with Veterans Boulevard
Run North with the Tupelo City Limits to the North Line of Section 21-T9S-R6E
Run West with the Tupelo City Limits to the NW Corner of Section 21-T9S-R6E
Run North with the Tupelo City Limits to the NE Corner of the SE ¼ of Section 17-T9S-R6E
Run West with the Tupelo City Limits to the East ROW of Kansas City Southern Railroad
Run North East with the Tupelo City Limits along East ROW of Kansas City Southern Railroad to the South line of Section 5-T9S-R6E
Run West approximately 3-miles along section line to the SW Corner of Section 1-T9S-R5E and the Point of Beginning

LOWNDES COUNTY INELIGIBLE AREA

(9/30/90)

Begin at the Southeast Corner of Section 30, T18S, R19E;

Run North to the Northeast Corner of Section 6, T18S, R19E;

Run West to the Southwest Corner of Section 35, T17S, R18E;

Run North to the Northeast Corner of Section 22, T17S, R18E;

Run West to the Northwest Corner of Section 20, T17S, R18E;

Run South to the Southeast Corner of Section 7, T18S, R18E;

Run West to the Northwest Corner of Section 18, T18S, R18E;

Run South to the Tombigbee River;

Run Easterly to the section line and South to the Southwest Corner of Section 30, T18S, R18E;

Run East to the Northeast Corner of Section 32, T18S, R18E;

Run South to the Southwest Corner of Section 28, T18S, R18E;

Run East to the Southeast corner of Section 30, T18S, R19E, which is the point of beginning.

In areas where the boundary line coincides with a street or road, it has been determined that frontage on both sides of the road would be considered ineligible.



WARREN COUNTY INELIGIBLE AREA

(9/30/90)

Begin at a point on the Mississippi River near the Reid Bedford Bend and run due East to the Southeast corner of Section 40, T15N, R3E; run North to the Northwest corner of Section 23, T15N, R3E; run East to the Southeast corner of Section 17, T15N, R4E; run North to the Southwest Corner of Section 35, T16N, R4E; run East to the Southeast corner of Section 35, T16N, R4E; run North to the Northwest corner of Section 16, T16N, R4E; run due west to Highway 61; run North along Highway 61 to the point it intersects the South line of Section 27, T17N, R4E; run East to the Southeast corner of Section 27, T17N, R4E; run North to the Northwest corner of Section 21, T17N, R4E; run West to the Northwest corner of Section 19, T17N, R4E; run South to the Southeast corner of Section 30, T17N, R4E; run West to the Northwest corner of Section 20, T17N, R3E; run due South to the Mississippi River; run in a Southerly direction along the Mississippi River back to the point of beginning.

In areas where the boundary line coincides with a street or road, it has been determined that frontage on both sides of the street or road would be considered ineligible.



WASHINGTON COUNTY INELIGIBLE AREA

(9/30/90)

Begin at the Southwest corner of Section 30, T19N, R8W; run East to Northeast corner of Section 33, T19N, R8W; run South to the Southwest corner of Section 34, T19N, R8W; run East to the Northeast corner of Section 9, T18N, R8W; run South to the Southwest corner of Section 8, T18N, R8W; run East to the Northeast corner of Section 13, T18N, R8W; run South to the Northeast corner of Section 16, T18N, R8W; run East to the Southwest corner of Section 8, T18N, R7W; run South to the Southeast corner of Section 19, T18N, R7W; run West to the Northwest corner of Section 27, T18N, R8W; run South to the Southeast corner of Section 28, T18N, R8W; run West to the Northwest corner of Section 36, T18N, R8W; run South to the Southwest corner of Section 8, T17N, R8W; run South to a point half way between the Northwest corner and the Southwest corner of Section 14, T17N, R8W; run West of the Mississippi River.

In areas where the boundary line coincides with a street or road, it has been determined that frontage on both sides of the street or road would be considered ineligible.
