2. Eligibility

- a. **Eligible Applicants.** For-profit and nonprofit entities with relevant experience developing affordable housing are eligible to apply for these funds. Such experience may include owning, constructing, rehabilitating, managing, or operating affordable multifamily rental projects. Applicants must also demonstrate general financial experience and expertise and familiarity with the requirements of any related federal, state, or local housing programs that will be used in conjunction with HOME.
- b. **Eligible Use of Funds.** HOME can be used for the production, preservation, or rehabilitation of rental housing. Housing assisted with HOME funds must meet certain property standards that address various requirements related to housing quality, accessibility, and energy efficiency.



3. Program Description

a. **Goals and Objectives.** The goal of the HOME Program is to produce, preserve, and rehab rental housing for low- to very-low-income households. HOME funds distributed by this notice are intended to leverage other affordable housing funds to maximize the resources available to develop affordable housing. Funded recipients must comply with maximum per unit subsidy amounts, rent and income limits, property standards, and periods of affordability.
